To undertake the course you must be a member of the Hutt Valley branch of the NZDA, or be an affiliate club member (Full member of another NZDA branch), to become a member you can join on-line at <https://hvnzda.org.nz/> then click the link to process with your membership application. Senior membership is \$120.

The course fee is \$300, payment in full is required by **4<sup>th</sup> September 2018**. An \$80 deposit (refundable up to 31 days prior to the course starting) is required to accompany all applications. Thirty days prior to the course the deposit is **NOT** refundable if you withdraw. A final payment of \$220 is required to confirm your attendance.

Course participants that use one of the clubs eight rifles (.243 caliber) can hire them for \$80 for the duration of the course and are required to pay for the ammunition they use each weekend. Ammunition costs can be invoiced to the student and paid via the club website. There is no cost to use the .22 rifles and .22 Ammunition can be supplied at a cost if required or you can purchase yourself.

Application fees can be paid by Internet Banking or cash at a club meeting.
